This complaint is separately registered in respect of sompura lake situated in Hemmigepura ward, Rajarajeshwari nagara constituency. Complainant has stated that sompura lake, which is also called as sompura kere is in the custody of BDA. In the order dtd: 11.9.2018 the sompura lake is shown as chikkabanavara lake. It is ascertained that there is no lake with name chikkabanavara in Rajarajeshwari nagara constituency area. Therefore in future the lake may be referred to as sompura lake situated in Hemmigepura BBMP ward only.

In the report submitted by deputy conservator of forest BBMP it is mentioned that the lake is in good condition and no polluted substance are joining the lake. It is further stated that only the maintenance work is to be taken up and the said work will be taken up after the BBMP allot funds towards maintenance of the lake.

Complainant has stated in his complaint that there is flow of untreated sewage coming from Lingaderanahalli composting plant and there is rampant dumping of garbage into the lake.

Therefore if approved notice will be issued to the member secretary pollution control board to hear the steps taken to

prevent polluted substances entering the lake from Lingaderanahalli composting plant. Further since complainant had submitted that a small portion of the lake is encroached by the private person, the Tahasildar Bengaluru South Taluk and the Assistant Director of land records Bengaluru south taluk will be directed to get the sompura lake surveyed immediately and submit report as directed in order dtd: 15.11.2018.

The case may be taken up for hearing on 14.11.2019 at 3-00 PM.
