ORDER

No one is present on behalf of the complainant.

- 2. Smt. Bhupradha, Assistant Executive Engineer, BBMP, Bengaluru is present.
- 3. In my order dated 13-11-2018, I had directed the Assistant Director of Land Records (ADLR for short), Bengaluru South Taluk as well as the Tahsildar, Bengaluru South Taluk to get the lake in question surveyed and fix up the boundaries. Pursuant to the said order, communication dated 11-12-2018 has been sent by the ADLR, Bengaluru South District addressed to the ARE-1 pointing out that the Vibhutipura Lake does not fall within his jurisdiction and it comes within the jurisdiction of Bengaluru East Taluk.
- 4. In the light of the said communication, it is necessary to issue notice to the ADLR, Bengaluru East Taluk and the Tahsildar, Bengaluru East Taluk

to comply with the direction given by me at paragraph 4 of my earlier order dated 13-11-2018. It is useful to extract paragraph 4 of the said order, which reads as hereunder:

Smt. Chaitanya pointed out that a portion of the lake has been encroached. It is needless to point out that if any portion of the lake has been encroached, the encroachment has to be removed. For the said purpose, it is desirable to get the lake surveyed. The Bruhat Bengaluru Mahanagara Palike to coordinate with the Survey Department and get the lake surveyed for the said purpose. notice to Assistant Director of Land Records, Bengaluru South and also to the Tahsildar, Bengaluru South. Tahsildar shall take immediate steps to get Vibhuthipura lake surveyed and fix up the boundaries. On such survey, the Bruhat Bengaluru Mahanagara Palike to fix up the boundary and fence the lake. This is required to be done by the next date of hearing."

- 5. In the light of the statement of ADLR, Bengaluru South Taluk, ADLR, Bengaluru East Taluk and the Tahsildar, Bengaluru East Taluk are directed to take immediate steps to get the lake surveyed and fix up the boundaries after removal of encroachment.
- 6. Smt. Bhupradha submitted that the de-silting work, construction of Sewage diversion drain work has already completed been and pathway improvement work is to be done. She further pointed out that the security room his also been constructed and Home guards have been deployed. The statement made by her is placed on record. She has filed certain photographs showing the status of the area before de-silting and thereafter. She further pointed out that, in respect of pathway, the BBMP is required to lay Cabal and the said work will be completed within the period of two months from today and the said statement is placed on record.
- 8. In the light of the statement of ADLR, Bengaluru South Taluk, the ADLR and the Tahsildar

of Bengaluru East Taluk are directed to get the Vibhutipura Lake surveyed and fix up the boundaries after removal of encroachment within a period of eight weeks from today and file the status report with regard to the steps taken.
